## SET UP TIMES, RULES, AND REGULATIONS

**1. A limit of TWO PERSONS** is set for each booth, whether it is a 1, 2, or 3 table booth. Each exhibitor may bring only ONE person, either a helper or a spouse. Second name must be submitted no later than two weeks prior to the show. No collector may bring extra persons other than young children living at home. Only you and the adult listed in the form above have authority to attend Saturday and Sunday before the general public is admitted.

**2. SET UP SATURDAY:** The West field back gate will be open for entry starting at **9:00 A.M.** and will remain open until closing at **4:00 P.M.** Come set up your display and meet and swap with everyone from **9:00 A.M. to 4:00 P.M.**

**3. SET UP SUNDAY:** The BACK gate and buildings will be open at 6:00 A.M. for all exhibitors pre-registered on Saturday. Exhibitors not previously checked in will be met outside the BACK gate beginning at 5:30 A.M. to be processed. Customers will enter at 8:00 A.M. Please attend your booth by **7:30 A.M.**

**4. SECURITY:** American Security and Investigation is on guard Saturday, Saturday night, and Sunday.

**5. INSURANCE:** Exhibitors accept full liability for any injury or loss to themselves or their property and staff while attending the show. They expressly release the management from liability for any loss or injury.

**6. EXHIBIT CONTENTS:** We welcome every category of antique and collectible toy and doll as well as holiday heirlooms. Exhibitors may not display items other than these. Please bring tablecloths.

**7. SHOW TIMES:** Exhibitors must be set up by 7:30 A.M. Sunday morning and must remain set up until 3:00 P.M. The public will attend from 8:00 A.M. to 3:00 P.M. and will expect to see a full show. Exhibitors who start packing before 3:00 P.M. will risk losing their location.

**8. CANCELLATIONS:** Credit for cancellations allowed 2 weeks prior to show. \$25 charge for returned checks.

**9. NO SOLICITATION** OF DEALERS OR CUSTOMERS IS ALLOWED AT ANY TIME.
